

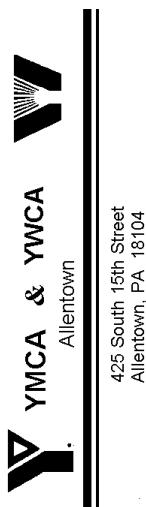
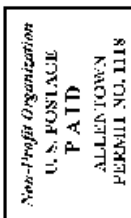

'SPORTSFEST' UNRATED EVENTS are only open to Non-USATT players/members.

Event numbers 1 & 11 – Novice ability level; 2 & 10 – Intermediate ability level; 3 & 9 – Advanced ability level. Event numbers 4 through 7 - age stipulations as of July 20TH 2008.

Event number 8 open to any age/ability female.

Event number 12 open to any age/ability level but must consist of one (1) male and one (1) female or two (2) females.

Players may only enter one (1) event with the same starting time. Players may enter a maximum of five (5) events.

ENTRY DEADLINE – Entries with appropriate fees must be post marked by Monday, July 14th, NO REFUNDS after July 9th.

DRESS CODE: Players MUST have two (2) different shirt colors available. No white or light colored shirts. Doubles teams please wear like colored shirts.

SERVICE RULES will be generally enforced – ball should be tossed up nearly vertical at least six (6) inches from an open, flat palm and contact should be in front of body. Serve sequence - Alternating with 2 serves each.

Pre-match warm-up time is limited to three (3) minutes.

All events are 'Paralympic friendly'.

Players are defaulted 15 minutes after event start time.

All events are Round Robin (winner advances to single elimination) or Double Elimination. Matches will be best 3 of 5, eleven (11) point games.

EQUIPMENT: 4 Harvard tables; 40 mm DHS white balls.

No sandpaper or 'sponge only' surfaces or 'fiberglass only' paddles allowed. Loaner paddles available.

POLICIES: Tournament coordinators may cancel, combine, or modify events as needed. If a class is cancelled, player is placed in next higher class. All events completed same day.

All matches must be played.

'SportsFest' Trophies awarded to 1st and 2nd places.

All 'SportsFest' entrants must add a \$4 registration fee.

REFRESHMENTS: Food, drinks, etc. available on site.

WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed to participate in the Lehigh Valley SportsFest, Inc. program, related events and activities, the undersigned acknowledges, appreciates and agrees that:

DIRECTIONS

FROM NORTH: Take PA Turnpike or Route 309 South to Lehigh Valley Exit (Route 22 East). Take Route 22 East to 15th Street Exit. Turn Right at traffic light to stop sign. Go straight to 12th light. You will be going down a hill approaching 12th light (Elm Street). YMCA/YWCA building on left at light.

FROM WEST: Take Interstate 78 East to Route 22 to 15th Street Exit. Follow NORTH directions.

FROM NORTHEAST: Take Route 33 South to Route 22 West to 15th Street Exit. Turn Left at traffic light to next traffic light. Follow NORTH directions.

FROM EAST: Take Interstate 78 West to Allentown Exit 57 (Lehigh Street). Bear Right (North) to 3rd traffic light (Arby's on Right). Turn Left to 2nd traffic light (2 miles). YMCA/YWCA building on right.

FROM SOUTH VIA PA TURNPIKE: Take PA Turnpike to Northeast Extension Exit 33 (Lehigh Valley) and take Route 22 East to 15th Street Exit. Follow NORTH directions.

FROM SOUTH VIA ROUTE 100: take Route 22 East to 15th Street Exit. Follow NORTH directions.

FROM SOUTH VIA ROUTE 309: Merge with Interstate 78 West. Follow EAST directions.
