### IMPORTANT INFORMATION

TEAM CAPTAIN ONLY must submit ALL team's entry forms with ALL appropriate fees in the SAME envelope. ALL participants must submit and sign a separate entry.

START TIMES – 9:00 a. m., however long distance teams will be notified if late start times are available. 'Top Gun' starts at approximately 3:30 p.m.

ENTRY DEADLINE – Entries with appropriate fees must be post marked by 7/12/10, NO REFUNDS after 7/1/10. NOTE: Maximum of teams [25] is firm and 1<sup>st</sup> paid entries received will be accepted. Entries received after deadline/quota will be returned.

CASH AWARDS: 'Team' awards are per team and cash awards are based on 25 total team entries and are subject to recalculation/revision if fewer enter and/or participate. (See awards section on reverse side.)

\*\* All USATT members are eligible for the 'Top Gun' events. Trophy awarded to 1<sup>st</sup> place winner of 'Top Gun' singles in BOTH classes.

POLICIES: Tournament coordinators may cancel, combine, or modify events as needed. All events completed the same day. Teams may consist of two or three players but only two may compete in singles in each team tie. NOTE – A & B TEAM 'TIES' will be played in the 'auditorium' (with a/c) and C-D-E in GYM #2.

USATT/ITTF RULES will be enforced – served ball must be tossed nearly vertical at least six inches from an open flat palm, and contact must be in front of body.

NO cell phones; NO flash photography; NO re-gluing.

DRESS CODE: TV/media insist team MUST wear 'LIKE' colored shirts while competing. Shirts, shorts (No white, orange or yellow colors allowed) and non-marking soft-soled shoes are required. All players and teams MUST have a second *different* 'like' shirt color available.

LOCKER ROOMS/SHOWERS available.

REFRESHMENTS: Food, drinks, etc. available on site.

THE 'A' TEAM & Top Gun 'A' Events are Karl Szakacs memorial events.

## Two-Player 'Team' Table Tennis

A team tie consists of two singles matches, one doubles match followed by one or two singles matches as necessary; Three match wins concludes the tie; matches will be best 3 of 5, eleven point games. All USATT rules (serve, dress, racquet, etc) will be enforced.

**FEES:** Team entry fee is \$86 (**Earlybird** entry postmarked by 7/1/10 only \$68). 'Top Gun' entry fee is INCLUDED for two players. Third team player **must** include \$15 extra.

**SEEDING:** Teams seeded by current **combined** average ratings; Top 5 in 'A' Division, next 5 in 'B', next 5 in 'C', next 5 in 'D', next 5 in 'E'. FORMAT is R/R.

### 'Top Gun' Singles Event(s)

**FEES:** Two 'Team' players are Automatically Entered FREE.- 3<sup>rd</sup> team player **must** include \$15 extra. \*\*Players competing ONLY in 'Top Gun' – Total fee w/processing is \$22. Begins at approximately 3:30 pm.

**SEEDING:** Top 20/24 USATT rated players are entered in 'A' – all others in 'B'.

**FORMAT:** SINGLE ELIMINATION ('A' semi finals are round robin).

**MEMBERSHIP:** All players must be members of USATT through July 2010 or must include payment for the appropriate level. Players that do not have an established USATT rating, **see** \* on entry blank. USATT adult membership: \$40 (1 year), \$105 (3 years) or \$650 (Lifetime). Junior membership or college (WITH PROOF) \$20 (1 year). All members receive the USATT magazine, an official rating, and may enter any USATT sanctioned event.

### DIRECTIONS

**FROM NORTH:** Take PA Turnpike or Route 309 South to Lehigh Valley Exit (Route 22 East). Take Route 22 East to 15<sup>th</sup> Street Exit. Turn Right at traffic light to stop sign. Go straight to 12<sup>th</sup> light. You will be going down a hill approaching 12<sup>th</sup> light (Elm Street). YMCA/YWCA building on left at light.

**FROM WEST:** Take Interstate 78 East to Route 22 to 15<sup>th</sup> Street Exit. Follow NORTH directions.

**FROM NORTHEAST:** Take Route 33 South to Route 22 West to 15<sup>th</sup> Street Exit. Turn Left at traffic light to next traffic light. Follow NORTH directions.

**FROM EAST:** Take Interstate 78 West to Allentown Exit 57 (Lehigh Street). Bear Right (North) to 3<sup>rd</sup> traffic light (Arby's on Right). Turn Left to 2<sup>nd</sup> traffic light (1 mile). YMCA/YWCA building on right at Elm Street.

**FROM SOUTH VIA PA TURNPIKE:** Take PA Turnpike to Northeast Extension Exit 33 (Lehigh Valley) and take Route 22 East to 15<sup>th</sup> Street Exit. Follow NORTH directions.

**FROM SOUTH VIA ROUTE 100:** take Route 22 East to 15<sup>th</sup> Street Exit. Follow NORTH directions.

**FROM SOUTH VIA ROUTE 309:** Merge with Interstate 78 West. Follow EAST directions.
